We offer 30 hrs funding childcare for eligible families **stretched** over each term.

- **Summer Term** 01st April to 31st August - 390 funded hours stretched over 22 weeks - **18 funded hrs per week**
- **Autumn Term** 1st September to 23rd December - 420 funded hours stretched over 16 weeks - **26 funded hrs per week**
- **Spring Term** 1st January to 31st March - 330 funded hours stretched over 13 weeks - **25 funded hrs per week**
